**Important Information for appellants seeking denial of a Short Term Residential rental unit permit**

Short-Term residential Rental unit (STR) permit appeals will be heard by a hearing officer, according to section 84.28.090(c)(2) of the San Bernardino County Code (County Code). Key points to be aware of:

- The hearing officer will hear from the appellant, the permittee and County Code Enforcement staff.
- Witnesses will be required to swear or affirm to the hearing officer that their testimony is the truth.
- The only valid grounds for granting an appeal and denying the STR permit shall be, based on competent evidence, violation of the STR permit requirements, violation of the conditions of operation or violation of the general occupancy standards in sections 84.28.060(b)-(c), and 84.28.070 of the County Code.

**Non-refundable appeal fee of \$100**

Your appeal will not be accepted unless a check or money order is included with this appeal form. This appeal fee is not refundable. \$100 appeal fee and form must be submitted in person or by mail to:
